#### **2023 COUNCIL STIPENDS**

We will again be offering two stipends to councils for 2023, upon request. First, the virtual meeting stipend is again a lump sum of \$180. This stipend is also available to the virtual councils. Second, the travel stipend of \$1,250 for geographic councils is based on 2,000 miles at the 2023 IRS rate (\$.625/mile), but councils may use the funds to pay for any travel expenses necessary to visit member chapters (i.e. lodging). The visits may be conducted by the council president or by any council officer they designate, and accounting is expected to be done at the local level.

No claims need to be submitted to national, but we do ask that you submit visit reports, as they might be considered for Levels of Excellence award purposes. Council presidents are asked to kindly signal your intent for both virtual meeting and travel stipend, or intent not to receive the stipends, to <a href="mailto:chapters@moaa.org">chapters@moaa.org</a>.

'Widow's Tax' on Survivors Will Be Completely Gone as of Feb. 1 Benefit Checks | Military.com -- This will officially end the discriminatory practice of denying benefits rightly deserved! As you may know, Congress made changes to the Survivor Benefit Plan (SBP) to phase out the offset for surviving spouses who are also receiving Dependency and Indemnity Compensation (DIC) from the Department of Veterans Affairs (VA). On January 1, 2023, the SBP-DIC offset was fully eliminated. That means SBP payments will no longer be offset (reduced) by DIC. Spouses will receive full SBP (issued by DFAS) and full DIC (from the VA). There is no action you need to take as a retiree for the changes to apply to your surviving spouse. However, you should check your RAS to ensure your SBP beneficiary is up to date. This is especially important if you have a former spouse.

### **VA Disability Compensation**

For those veterans who are unfamiliar with VA Disability Compensation, this article will give them the basic information they need to answer the following questions:

- 1. What is disability compensation?
- 2. What is military service-connection?
- 3. How does the Veterans Benefits Administration (VBA) compute and assign a VA disability rating?
- 4. Where can a veteran get help with understanding their VA benefits and how to file for those benefits?
- 5. Where can I get more information on VA Disability Compensation?

#### What is disability compensation?

According to the Veterans Benefit Administration (VBA) webpage titled VA Disability Compensation, (<a href="https://www.benefits.va.gov/compensation/index.asp">https://www.benefits.va.gov/compensation/index.asp</a>) and VBA You Tube Video titled Compensation 101: What Is Disability Compensation? (<a href="https://bit.ly/3xYtwNe">https://www.youtube.com/watch?</a> v=T3RodE0nGFc), VA disability compensation offers a monthly tax-free payment to veterans who got sick or injured while serving in the military and to veterans whose service made an existing condition worse.

Veterans may qualify for VA disability benefits for physical conditions (like a chronic illness or injury) and mental health conditions (like PTSD) that developed before, during, or after service. A veteran must also have separated or been discharged from service under other than dishonorable conditions to be eligible for disability compensation.

For a veteran to be eligible for Disability Compensation, the injury or disease must have been: (1) sustained in the line of military duty or (2) a pre-existing injury or disease must have been aggravated by military duty. For a veteran to be eligible for Disability Compensation, the injury or disease must have been: (1) sustained in the line of military duty or (2) a pre-existing injury or disease must have been aggravated by military duty.

How to file for worsening conditions, how to request a decision review or manage a legacy appeal, add or remove a dependent, upload evidence to support your disability claim, and file additional forms for your disability claim.

Change your VA direct deposit information, share your medical records, download your VA benefit letters, and view your VA disability payments history.

#### What is military service-connection?

As stated in VA You Tube Video titled *Compensation 101: What Is Service Connection?* (https://bit.ly/3kwLGSW or https://www.youtube.com/watch?v=h4vKqUlrdys) and VA webpage titled *Compensation*, https://www.benefits.va.gov/compensation/index.asp, service-connection describes an injury or disease resulting in a disability linked to a veteran's military service. The VA grants service-connected disability when evidence shows a link between a claimed medical condition and military service.investigations, accident reports, serious incident reports, officer and enlisted efficiency reports, photographs, and other corroborating information.

### VA uses chronicity and continuity principles to evaluate claims for Service-Connected Disability Compensation

Principles relating to VA service-connection are discussed in 38 Code of Federal Regulations (CFR) 3.303. The VA uses two primary principles to evaluate evidence supporting a service-connected disability claim. The VA uses *Chronicity* to look for the combination of evidence to show the claimed condition has been medically diagnosed as chronic and not an isolated finding during military service. Examples of chronic diseases include Arthritis and Multiple Sclerosis.

Calculating a veteran's combined disability rating involves more than adding up your individual ratings. That is why the veteran's combined rating may be different from the sum of his or her individual ratings.

The VA uses a concept called the "Whole Person Theory" to determine a veteran's combined disability rating. This method ensures that a disability rating can never be greater than 100%, since a person cannot be greater than 100% able bodied. If chronicity cannot be established then the VA uses evidence showing *Continuity* of a disability or symptoms to help establish whether an injury or illness is service-connected. For example, a veteran named Danny files a claim for service-connected disability for a left ankle he injured, when he slipped and fell off the top of a wet helicopter roof. Danny may be able to show the VA that he complained of the left ankle to his comrades after the injury and complained to his wife, civilian employer, and doctor of his ankle hurting for months after his military discharge. If Danny provides the VA with a current medical diagnosis from his civilian doctor of a left ankle injury and condition (along with any other evidence he has like Lay Witness Statements), he is almost certainly going to be able to prove continuity and military service-connection.

If a veteran has multiple disability ratings, the VA uses them to calculate the veteran's combined VA disability rating. #### **Surviving Spouse Corner:**

## **Looking Back On 2022**



MOAA's Surviving Spouse Advisory Council saw many accomplishments this year — participating in advocacy efforts, educating fellow MOAA members, and giving back to their communities.

Surviving spouses comprise approximately 13% of MOAA's membership — that is over 46,000 members, voices, voters, givers, and doers. The Surviving Spouse Advisory Council (SSAC) represents these 46,000 members by supporting surviving spouses and spouses and promoting MOAA's strategic priorities at every opportunity through education, encouragement, and engagement.

In 2022, surviving spouses led MOAA chapters as president, secretary, treasurer, newsletter editor, program director, and legislative chair and created and managed community programs. We conducted five surviving spouse liaison trainings for over 100 surviving spouse liaisons, spoke at more than two dozen chapter meetings, wrote 12 articles, contributed to more than 100 Advocacy In Action sessions, and participated in 12 virtual meetings with over 500 total participants. We also organized and participated in a surviving spouse/spouse summit that attracted more than 80 participants. Here's a closer look:

**Surviving Spouse Liaison Training:** SSAC member training was held during regional leadership workshops in Florida, Washington, North Carolina, Nebraska, and Texas. Average attendance for each workshop was 80, with about 20 attending the Surviving Spouse Liaison Training. SSAC members continue to fine-tune the training based on new information, evaluations, and comments from participants.

**Surviving Spouse Virtual Chapter:** Membership continues to grow, with 210 members from 38 states. The chapter meets on the third Tuesday of each month. Every other month is a business meeting with a speaker, and alternate months are an informal gathering to exchange information and ideas. Attendance varies but usually includes 30 at the social meetings and about 60 at the more formal meeting. <u>Learn more about the chapter online.</u>

**Articles for MOAA Newsletters:** SSAC members wrote monthly Surviving Spouse Corner columns, which are published the first Thursday of each month in *The MOAA Newsletter*. <u>Read past Surviving Spouse Corners.</u>



MOAA's Surviving Spouse Virtual Chapter is an affinity group whose members share information and ideas with others in a virtual environment. After starting the virtual meetings through quarterly teleconferences, the Surviving Spouse Virtual Chapter now meets monthly through Zoom. Almost 40 states are represented in the membership. This chapter is intended to be an enhancement to, rather than take the place of, geographic chapters, and there are no dues.

Several weeks in advance of each meeting, members receive an email alerting them to the date and time of the gathering; a follow-on email with instructions for joining is sent several days prior to each meeting. The session is kept to an hour and a half and members can log on or off according to their schedule. Topics of discussion and presentations have included Survivor Benefit Plan-Dependency and Indemnity Compensation offset updates, financial information, and updates from MOAA national as well as other items of interest.

Members participate to the extent they are able. While the chapter is geared toward surviving spouses and surviving spouse liaisons, any MOAA spouse is welcome for membership. MOAA's mantra "Never Stop Serving" is espoused to make a difference locally, statewide, and nationally.

# ADVOCACY IN ACTION

#### MOAA IN ACTION: MAJOR LEGISLATIVE ACCOMPLISHMENTS

#### (Updated Feb. 8, 2023)

MOAA engages with Congress on all manner of issues related to the uniformed services community. These efforts can include collaboration with other like-minded organizations and with The Military Coalition. We also rely heavily on our members who make their voices heard by contacting lawmakers via MOAA's Legislative Action Center, by participating in our annual signature advocacy event, and through local efforts at the chapter and council level.

For <u>more than 90 years</u>, this work has led to real results – pay and benefits protected from budget-driven threats, continued access to quality medical care, and countless other areas of concern to our members, our military, and the wider uniformed services community.

No list could encompass everything MOAA's achieved since 1929, but below, you'll find some of the highlights, broken into six categories. #### **MAINTAINING PAY RAISE COMPARABILITY**

A quick look <u>at this list</u> and others like it show the wide range in year-over-year pay raises among the military community. MOAA has fought to ensure those who serve get what they've earned, and has been part of efforts in recent years to secure the <u>largest raise in a decade</u>.

This work hasn't always broken records, but it's proceeded, largely with success, toward a goal of pairing <u>raises with</u> the <u>Employment Cost Index (ECI)</u>, a metric that, by statute, links military pay increases with civilian economic indicators. The basic pay raise has not dipped below ECI since FY 2016.

This work not only benefits the current force but helps increase the base pay for future military retirees, which will lead to greater benefits after service.

#### **RETIREES**

#### **INCREASING SGLI AND VGLI COVERAGE**

The Supporting Families of the Fallen Act was signed into law in 2022. The maximum Servicemembers' Group Life Insurance (SGLI) coverage will move from \$400,000 to \$500,000 as of March 1, 2023, and all eligible servicemembers will be enrolled to receive that new maximum, even if they've previously declined coverage. The long-overdue increase became law as part of the MOAA and TMC backed Supporting Families of the Fallen Act, which also increased Veterans' Group Life Insurance (VGLI) coverage by the same amount.

#### PROTECTING TRICARE FOR LIFE\*

The TRICARE For Life (TFL) program launched in 2001. Since then, TFL has come under budgetary attack in multiple legislative cycles, with MOAA and other advocacy groups working to preserve the benefit for Medicare-eligible uniformed services retirees and their families.

MOAA's advocacy efforts, including congressional testimony, statements for the record, and engagement with Armed Services Committee staff and member offices on Capitol Hill, successfully blocked five consecutive administration budget request proposals for a TFL enrollment fee in fiscal years 2013-2017.

These proposals included enrollment fees based on military retirement income level that would have been indexed annually based on either retiree COLA or health care inflation

#### REFERENCE INFORMATION SECTION

#### **MOAA GUIDANCE ON PARTISAN POLITICAL ACTIVITIES**

#### **PARTISAN POLITICAL ACTIVITIES**

As organizations exempt from federal taxation under Sec. 501(c)(19) of the Internal Revenue Code, MOAA and its affiliates must take care to avoid engaging in partisan political activities. Under IRS rules, we are prohibited from directly or indirectly participating in, or intervening in, any political campaign on behalf of (or in opposition to) any candidate for public office.

#### CANDIDATES FOR PUBLIC OFFICE

A candidate for public office is an individual who offers himself or herself, or is proposed by others, as a contestant for an elective public office, whether such office is national, state, or local, and includes incumbent candidates. The prohibition also extends beyond declared candidates and may apply to efforts to recruit an individual to run for office or advance exploratory activities. The prohibition also applies to advocating for the platform of one political party over another.

#### **PROHIBITED ACTIVITIES**

Activities which constitute participation or intervention in a political campaign on behalf of or in opposition to a candidate include, but are not limited to, the publication or distribution of written or printed statements or the making of oral statements on behalf of or in opposition to such a candidate.

It is clear that the prohibition on partisan political activity prohibits such outright actions such as posting a "Vote for Biden" or "Vote for Trump" on the organization's website, or "Support Republican Candidates" or "Vote Democratic."

In addition to these obvious examples, the prohibition goes well beyond direct expressions of support. In determining whether an organization is engaged in unlawful partisan political activities, the IRS applies a "facts and circumstances" test. The IRS looks not only to the expressed language, but to external factors, such as the communication's timing, its targeted audience, and how the message relates to public policy positions that distinguish a candidate in a campaign.

#### **CONSEQUENCES FOR VIOLATIONS**

The consequences to an organization that violates the prohibition on partisan political activity can be severe including the loss of its tax exempt status and the imposition of certain excise taxes. For public charities, like The MOAA Foundation and the MOAA Scholarship Fund, the IRS can disallow tax deductions for charitable contributions. In addition, for an organization whose mission involves advocacy on key military community issues, MOAA must seek support from elected representatives from both parties.

Engaging in partisan political activities on behalf of one party or candidate would seriously undermine MOAA's ability to achieve the bipartisan consensus on key issues essential to achieving its legislative objectives.

#### MOAA GUIDANCE ON PARTISAN POLITICAL ACTIVITIES, CONTINUED

#### **PERSONAL OPINIONS**

As individuals, members and leaders of MOAA and MOAA's affiliates are not prohibited from engaging in partisan political activities so long as they do so in way that makes it clear they are acting for themselves and do not appear to be speaking on behalf of MOAA or its affiliates. For example, it is permissible for an individual to express his or her personal preference in support of or in opposition to a candidate or political party. And they may do so publicly.

However, when expressing their personal opinions or preferences, they may not make reference to their MOAA position, use MOAA communications channels, use MOAA letterhead or newsletters, identify themselves as MOAA leaders, or imply that MOAA or its members share their beliefs.

#### **LEADERSHIP RESPONSIBILITIES**

Those in leadership positions have a special responsibility to separate their personal political opinions from statements that are or can be attributed to MOAA or its affiliates. For example, it is improper for a chapter leader to use the chapter's newsletter to advance the leader's personal political beliefs.

This goes beyond statements expressly advocating for a specific candidate or party by name. Statements that incorporate campaign messaging, campaign slogans, and political positions identified with a particular candidate or party are also prohibited. No MOAA leader is authorized to use MOAA's or an affiliate's resources to communicate their personal political beliefs. This is an outright violation of the leader's fiduciary duty to the organization and a serious leadership and ethical failure.

#### **DIVISIVE SOCIAL ISSUES**

We are all aware of the divisive nature of the debate over today's leading social issues — protesting during the national anthem at sporting events, racial justice, public protests, and the conduct of law enforcement officers. These are issues over which many Americans have deeply held, but differing, personal beliefs. This is also true within the military community among the ranks of active duty and retired officers and within MOAA itself.

MOAA leaders have an obligation to keep this in mind when communicating on behalf of MOAA or its affiliates. Suggesting that MOAA only supports one side of a deeply divisive issue sends a message to those with a different belief that MOAA is not for them.

Officers today have grown up in a military culture that is very different than the past. Many are accepting of attitudes and views that were not mainstream when many of us were in uniform. If MOAA is going to connect with the newest generation of uniformed officers, it needs to be clear that those with strong views on racial and social justice imperatives are just as welcome as those who adhere to more traditional expressions of patriotism and officership.

#### **PACT Act Related Effective Date Scenarios**

#### **Compensation Claims**

Scenario 1: Original Compensation claim was filed for a PACT Act presumptive condition within 1 year of the date the PACT Act was signed into law

What Actions Need To Be Taken: Submit a VA Form 21-526EZ claiming the PACT Act presumptive condition. On the VA Form 21-526EZ in Section IV: Claim Information, the box states: "If due to exposure, Event, or Injury, Please Specify", for this you will write **Toxic Exposure**. Additionally in Section IV it states: "Explain how the disability(ies) relates to the in-service event/exposure/injury, here you will write **Service in (xxxx)**.

Effective Date: The effective date will be August 10, 2022 – the date the PACT Act was signed

Scenario 2: Original Compensation claim for a newly added Pact Act Presumptive condition was filed after 1 year of the law change

What Actions Need To Be Taken: Same actions as Scenario 1

**Effective Date:** The effective date will be the date the claim was submitted.

Scenario 3: Intent to File was submitted within 1 year of the PACT Act being signed into law and a compensation claim for a newly added PACT Act Presumptive condition is filed within 1 year of the ITF.

What Actions Need To Be Taken: Same actions as Scenario 1

**Effective Date:** The effective date will be August 10, 2022. This is due to the ITF preserving the date of law change as the effective date and the claim was submitted within the ITF window.

Scenario 4: Veteran was denied benefits for a PACT Act presumptive condition prior to the PACT Act being signed into law.

What Actions Need To Be Taken: Submit VA Form 20-0995 with a VA Form 21-4138 stating:

(Veteran's Name) has previously filed a claim for (condition) and this claim was denied on (date) due to (reason for denial). (Veteran's name) served in (location) from (dates of service in that location) and is now eligible for presumptive service connection under the PACT Act of 2022. Please accept this statement in conjunction with the law change as new and relevant evidence and review the veteran's claim for (condition). Your attention to this matter is greatly appreciated.

VA Form 20-0995 in Part II box 13A states to list the specific issues on appeal. Here you will write the condition and "Please see attached 21-4138 to satisfy requirement for new and relevant evidence."

**Effective Date:** The effective date will be August 10, 2022 or 1 year prior to the filing of the claim, whichever is later. The effective date cannot be earlier than August 10, 2022.

Scenario 5: Dependency Indemnity Compensation (DIC) claim was filed and denied *BEFORE* the PACT Act was signed.

What Actions Need To Be Taken: Submit A VA Form 21P-534EZ claiming DIC benefits, along with the death certificate and a VA Form 21-4138 explaining the surviving spouse was previously denied for DIC but is now eligible under the PACT Act.

**Effective Date:** The effective date will be the date the original DIC claim was filed.

#### Scenario 6: Dependency Indemnity Compensation (DIC) claim filed AFTER Pact Act was signed.

**What Actions Need To Be Taken:** Submit A VA Form 21P-534EZ claiming DIC benefits, along with the death certificate showing the veteran passed away from a PACT Act Presumptive condition.

**Effective Date is:** The effective date will be August 10, 2022 or 1 year prior to the filing of the claim, whichever is later. The effective date cannot be earlier than August 10, 2022.

Scenario 7: Intent to File was submitted within 1 year of the PACT Act being signed into law and a DIC claim for a newly added PACT Act Presumptive condition is filed within 1 year of the ITF.

What Actions Need To Be Taken: Same actions as Scenario 6

**Effective Date:** The effective date will be August 10, 2022. This is due to the ITF preserving the date of law change as the effective date and the claim was submitted within the ITF window.

When filing for an appeal of a previously denied PACT Act Presumptive, follow this example of a 20-0995 already filled in.

- DEATH GRATUITY A one-time, nontaxable payment to help surviving family members deal with the financial hardships that accompany the loss of a service member.
- SSSB Social Security Survivor Benefits are monthly benefits paid to eligible family members of a deceased service member who has worked and paid Social Security taxes.
- SSIA Special Survivor Indemnity Allowance is a benefit for surviving spouses who receive a Survivor Benefit Plan annuity that is offset by a Dependency and Indemnity Compensation payment from the U.S. Department of Veterans Affairs.
- SGLI Servicemembers' Group Life Insurance is life insurance coverage for a service member
- TSGLI Servicemembers' Group Life Insurance Traumatic Injury Protection is financial assistance for service members who incur physical losses due to traumatic injuries.
- FSGLI Family Servicemembers' Group Life Insurance is life insurance coverage for a service member's spous and dependent children
- DIC Dependency and Indemnity Compensation is a tax-free monthly payment to survivors provided by the Department of Veterans Affairs.
- SBP The Survivor Benefit Program is a taxable annuity for survivors paid through the Defense Finance and Accounting Service.
- TRICARE The uniformed services' health care program.
- DEA Dependents Educational Assistance is an educational benefit provided by the Department of Veterans Affairs.

This milestone guide outlines the change in benefits survivors can expect and what decisions a survivor may need to make.

## Travel Pay: How to Apply?

Sign in using your My HealtheVet credentials

Many Veterans can be reimbursed for travel costs related to VA health care services. <u>The Beneficiary Travel program</u> helps eligible Veterans receive mileage reimbursement.

Many things can make you eligible for travel pay. You can find the requirements <u>here</u>. Once you've determined your eligibility, you can use your My HealtheVet credentials to sign in. Here are step-by-step directions on how to apply for your travel pay reimbursements:

#### Visit the AccessVA website.

- •Then, select 'I am a Veteran.'
- •Select the 'Veteran Travel Claim Entry' button.
- •Select the green 'Access VA' button.
- •Then, select the 'Sign in with My HealtheVet' button (or another sign-in option).
- •A pop-up box will appear. Select 'Accept' to move forward.
- •Once you sign in, you'll go to the welcome page. Then, agree to the Terms and Conditions.
- •Review your profile and go to your dashboard.

Once it's time to create a claim, follow these steps:

- •Go to "My Appointments."
- •Select the blue 'Create Claim' button for the appointment you're claiming travel pay for.
- •If you do not see your appointment listed, select 'Create' in the upper right corner, then select 'Add New Appointment.'
- •Confirm address on the page. Then select 'Create a Claim' and 'Add Expenses.'
- •Once your claim is created, review the Beneficiary Travel Agreement Notice and check the box to show your agreement. Then select 'Submit Claim.'

If you're signing into AccessVA with your My HealtheVet credentials, you'll need a My HealtheVet Premium account. Upgrade to a free <a href="Premium">Premium</a> account now.
